## **Riverbend Primary School's 2021 Digital Technologies: Acceptable Student User Agreement**

*At Riverbend Primary School we are committed to supporting our students in becoming smart, safe, responsible and ethical users of digital technologies both at school and as part of greater society.*

**As a student at Riverbend Primary School, I understand using an iPad at school as a tool for learning is a privilege. When I use my iPad at Riverbend Primary School I will abide by the school's expectations:**

- I will take full responsibility for the iPad, only accessing and using my own or assigned device.
- I will ensure the iPad is always in a protective cover and clearly labelled for identification.
- I will bring my iPad to school each day, ensuring it is charged and ready for use.
- I will keep my iPad in my school bag when transporting it to and from home.
- I will not access my iPad on the way to school or on the way home unless I am under the supervision of my parent or carer.
- When the iPad is not being used I will store it in the designated storage place as directed by the teacher.
- I will only carry or use the iPad outside when permission and supervision by the teacher is given.
- I will keep food and drinks away from the iPad at all times.
- I will immediately report any accidents, breakages or malfunctions to my parent or carer and teachers.
- When at school, I will not send or receive messages from others via airdrop, text, FaceTime or email that are not school related unless permission from a teacher is given.
- I will not use apps deemed only for home use while at school unless permission from a teacher is given.
- I will only use the iPad to support my school learning program during school hours.
- I will act responsibly and not use the iPad to find, create or send information that might be harmful, inappropriate or hurtful to me or anyone else.
- I will access online sites and spaces that are appropriate and if unsure I will ask a trusted adult for help.
- With the exception of my teachers and parent or carer, I will not disclose my passcode or passwords to others.
- I will protect my identity when online by ensuring that personal information including my full name, photos, address and birthday etc. is not shared
- I permit my parent or carer and teachers to perform checks to monitor my iPad use, inclusive of my apps, photos and internet usage.
- I understand that taking photos, videos or recording voice of any individual or groups **is not allowed without the express permission** of all the individuals being recorded and with the permission of the teacher.
- I will not post any school related photos or videos on the iPad to social media sites unless permission from the teacher is given.
- I will speak to a trusted adult in the event when I am online and I witness something that makes me uncomfortable or upset and/or if I need help to support myself or another person.
- I will only use the school's wireless network, and if my iPad has a phone internet connection it **must** be switched off at school.
- I will back up my iPad data on a regular basis and ensure that I manage the storage capacity to allow for school related tasks to be stored.

**I acknowledge and agree to follow these expectations. I understand that breaches of these rules may result in the loss of my technology rights and use of the iPad at school for a period of time determined by my teacher and the Principal.**
